May 2016

Significant Events:

On the following dates/times Elsmere Bureau of Police officers handled the below incidents and seized the following drugs, money and weapons during the month.

April 10, 2016:

At 3:40 p.m. Ptlm. Wingate was on routine patrol of Beech Avenue when he observed a light blue 2003 Buick LeSabre with Delaware registration driving south bound toward "I" Alley. The vehicle failed to signal before turning and a vehicle stop was conducted.

Ptlm. Wingate made contact with the 50 year-old driver John Cassidy. Def. Cassidy stated that he was on his way to visit his girlfriend who is a known drug user.

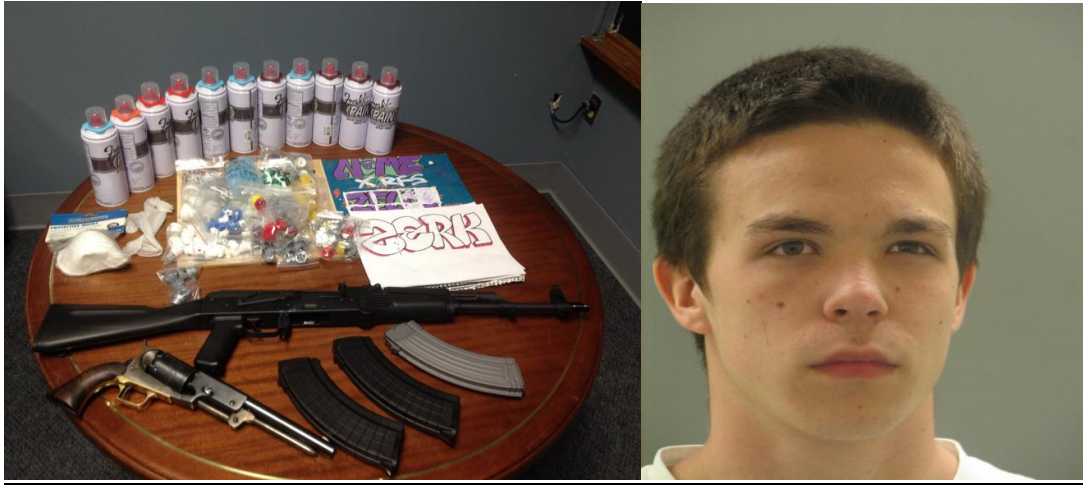
After further interaction with the Def. the officer found him to be in possession of 7 bags of heroin, 0.3 grams of crack cocaine, and 1 smoking pipe. Def's vehicle was towed for lack of insurance and the defendant was taken into custody without incident. The defendant was charged with 2 counts of Possession of a Controlled Substance, Possession of Drug Paraphernalia, and traffic violations. Def. was given \$2,300.00 unsecured bail along with a no contact order with the Town of Elsmere.

April 13, 2016:

While on patrol PFC. Giles stopped Jacobi Maloney-Barnhill, 21 year old male from the 400 block of South Union Street located in the City of Wilmington after as he was observed walking behind a closed business. During the stop it was discovered that Jacobi had just damaged a sign and dumpsters in the area with graffiti tag of "ZERK". A search warrant was executed for the suspect's residence and evidence was found linking the suspect to 20+ additional graffiti incidents in the Town of Elsmere. Also located was marijuana, an AK-47 rifle with ammunition, an unknown caliber handgun, and numerous graffiti tools and paraphernalia.

The suspect was arrested for Graffiti/Criminal Mischief, Criminal Trespassing, Loitering, Possession of Graffiti Implements/Tools, Possession of Marijuana, and Possession of Firearms by a Person Prohibited. The suspect was released on unsecured bail and ordered to have no contact with the Town of Elsmere.

April 15, 2016:

Cpl. Scot Sowden responded to 900 block of New Road for the report of a male subject who collapsed. Cpl. Sowden arrived on scene and made contact with a 36 year old male subject who was awake but not coherent. After speaking to the subject for several minutes, the subject closed his eyes and would not respond to any questions or physical stimulus. Cpl. Sowden was able to speak with the victims family members who arrived on scene and they told him that the victim used heroin prior to collapsing. Cpl. Sowden administered one (1) dose of Naxolone and after several seconds the victim regained consciousness and was able to tell Cpl. Sowden that he used too much heroin. The victim was transported to an area hospital for observation.

April 20, 2016:

At approximately 11:00 p.m. PFC Giles conducted a motor vehicle stop in the 1200 block of Maple Avenue for a traffic violation. The driver was identified as Ignacio Reyes-Hernandez, a 27 year old male from the 800 block of W. Champlain Avenue. During the stop a loaded Kel-Tec 9mm handgun was located under the driver's seat, and a loaded Hi-Point .45 caliber handgun was found concealed in the trunk. Upon further examination both firearms had their serial numbers obliterated.

Ignacio Reyes-Hernandez was charged with two counts of Carrying a Concealed Deadly Weapon/Firearm, two counts of Possession of a Weapon with an Obliterated Serial

Number and several traffic violations. He was committed to Howard Young Prison after failing to post \$10,000.00 cash bail.



April 27, 2016

On Wednesday, April 27th, PFC Giles was enroute to Elsmere when he observed a vehicle driving erratically on Route 141. PFC Giles initiated a traffic stop and contacted the defendant Baukeif Munyan, a 21 year old male from the 800 block of W. 34th Street in the City of Wilmington.

During the stop PFC Giles detected the odor of marijuana and had the defendant exit the vehicle. After searching the vehicle a concealed and loaded Walther .380 caliber handgun was located along with marijuana. The defendant is a person prohibited from possessing a firearm and had an active Family Court (PFA) Protection From Abuse Order.

Baukeif Munyan was charged with the following; Possession of a Firearm by a Person Prohibited, Possession of Ammunition by a Person Prohibited, Carrying a Concealed Deadly Weapon, Possession of Marijuana and traffic offenses. Munyan was committed to Howard Young Correctional Facility on \$53,000.00 bail.
