Town of Elsmere Ranked Safest City

On February 22, 2017, WDEL reported that the National Council for Home Safety and Security ranked the Town of Elsmere as the safest city in the state.

The National Council for Home Safety and Security said Elsmere is the safest place in the state that provided a complete crime report to the FBI with a population of at least 5,000 residents. Elsmere ranked below the national and state averages in violent and property crimes. Elsmere's violent crime average was 2.27 for every 1,000 residents and 17.21 for property crimes.

Burglary In Progress

On Wednesday, March 1, 2017 at approximately 10:40 p.m., Cpl. Davis, PFC Wingate and New Castle County PD officers responded to the unit block of Harvey Place for an occupied burglary in progress.

Upon arrival, officers observed three suspects along the side of the residence attempting to gain entry through a side window. All three suspects fled on foot. One subject was apprehended and officers are attempting to identify the two subjects still at large.

Officers arrested John Shields of the 400 block of S. Jackson Street, Wilmington. Defendant Shields was charged with Burglary 2nd, Possession of Burglary Tools, Conspiracy, Criminal Mischief and Resisting Arrest. Def. Shields received \$8,600.00 secured bail and was committed to Howard Young Correctional Institution.

Child Abduction

On May 8, 2017, Colonel Bond of the New Castle County Police Department held a news conference announcing the arrest of Daniel M. Santucci, Jr. in connections with the April 6th abduction and sexual assault of a 4-year-old girl from the community of Village of Plum Run.

During Colonel Bond's news conference, he acknowledged the Elsmere Bureau of Police for providing investigators with the lead that ultimately led to Daniel Santucci as the primary person of interest.

Daniel M. Santucci, Jr, of the 600 block of New Road in Elsmere, was charged with first-degree attempted murder, first-degree kidnapping, unlawful sexual contact with a person under 13 years old, and possession of child pornography. He was arraigned and committed to Howard Young Correctional Institution after failing to post \$1,076,000 cash only bail.

LATE NIGHT FOOT PATROLS CATCH BURGLARS IN THE ACT

On Thursday, July 20, 2017 at 3:00 am, PFC Giles and PFC Wingate were conducting foot patrol along Maple Avenue. While in the area of Maple Avenue and Tamarack Avenue, officers observed two suspects breaking in to parked vehicles. Officers hid behind parked vehicles and continued to watch the suspects from a distance. When the suspects reached Maple Avenue, the officers quickly emerged and took them in to custody before they could had a chance to flee. The suspects were identified as 20-year-old Michael Sanders of the 2600 of Bowers Street, Wilmington and 18-year-old Nijir Lee of the 1900 block of Prospect Road, Wilmington. Officers located stolen property on both suspects and both were charged with the following; Night Prowling, Conspiracy 2nd Degree, Trespassing 3rd Degree, Burglary 3rd Degree, and Theft. Both suspects were released on \$2000.00 unsecured bail and ordered to have No Contact with the entire Town of Elsmere.

NEIGHBORHOOD SURVEILLANCE CAMERA CATCHES BURGLAR IN THE ACT

On Wednesday, July 19, 2017, PFC Wingate responded to the 100 block of Ohio Avenue for a residential burglary. The estimated value stolen from the residence was valued over \$2,000.00. PFC Wingate was able to identify a suspect due to a neighbor having surveillance cameras, which captured Defendant Tyler Wilson from the 200 block of East Greenbank Road, Wilmington, gaining access into the residence.

Wilson was arrested and charged with Burglary 2nd, Theft, Theft By False Pretense and Selling Stolen Property. He was arraigned by Justice of the Peace and released on \$6,000 unsecured bail.

OFFICER ATTEMPTING TO RENDER MEDICAL AID TURNS IN TO DRUG DELAING ARREST

On Thursday, July 27, 2017, PFC John Giles was clearing an incident in the area of the Elsmere Police station. PFC Giles noticed a vehicle parked in the neighborhood with a subject slumped over the center console and stopped to check on the subject who was later identified as Terrance Caldwell of the 2500 blk. of N. Van Buren Street, Wilmington.

While approaching the vehicle, PFC Giles noticed a cap of a syringe near the driver side door. Several attempts were made to get the attention of Caldwell from outside the vehicle with no success. Fearing Caldwell could be suffering from a medical emergency; PFC Giles opened the door and attempted to awaken Caldwell. While awakening Caldwell, PFC Giles observed him grab his waistband and grasped an unknown object. Caldwell was patted him down for officer safety and a folding knife, 1.9g crack cocaine packaged for sale, 52 bags of heroin and \$300+ in suspected drug proceeds.

Caldwell was charged with Possession of a Controlled/Counterfeit Substance with the Intent to Distribute (x2). He was released on \$20,000.00 unsecured bail.

Shots Fired At Officer

On Thursday, July 27, 2017, at approximately 6:45 pm PFC West and Ptlm. MacDowell assisted New Castle County PD with a robbery that had just occurred in Westover Hills. An NCCPD officer was checking the area and located a person matching one of the suspect's descriptions. When the officer attempted to stop the suspect, the suspect drew a firearm from his waistband and fired at the officer. The officer returned fire and a foot pursuit ensued. Ptlm. MacDowell was the first unit to the officer and assisted in taking the suspect into custody. PFC West arrived shortly after and advised responding units the direction of travel of the two suspect still at large.

SUSPICIOUS PERSON APPREHENDED AFTER FOOT CHASE

On Tuesday, August 15, 2017, at approximately 9:30 pm, PFC Giles was patrolling the area of Vilone Village to address several recent complaints of nighttime vehicle break-ins. While in the area of Casapulla Avenue and Junction Street, the officer observed William Sharp, from the unit block of Vincent Ct. Bear, carrying a book bag and acting suspiciously near a parked vehicle. As the officer approached, he began to walk away from that vehicle and pretend he was talking on the phone. The officer stopped Sharp on Casapulla Avenue and asked what he was doing in the area. When the officer attempted to identify Sharp he immediately fled on foot. PFC Giles chased Sharp through several yards and caught him in the unit block of Vilone Road where he continued to resist arrest. As the officer was able to place Sharp in custody, several officers from the New Castle County Police responded to assist in checking the development for any apparent vehicle break—ins. The investigation determined Sharp was not in possession of any stolen property, but that he had \$50,000.00 CASH capias issued for failing to appear for a drug and firearm trial. Sharp was additionally charged with Resisting Arrest and committed to Howard Young Correctional Center for failing to post bail.

CONVERSATION DURING TRAFFIC STOP LEADS TO BURGLARY ARREST

On Wednesday, August 16, 2017, Ptlm. Macdowell conducted a traffic stop for a seatbelt violation in the development of Rosemont. While identifying numerous occupants in the vehicle, Ptlm. Macdowell determined that the information he received from one passenger was not adding up. The officer continued to investigate the information and was ultimately able to identify the suspect as Ericka Jenkins of the 100 block of Stamm Blvd., New Castle, DE. Jenkins was wanted on a burglary warrant and was taken into custody and turned over to Wilmington Police Department.

Officers are often asked why they need to identify all occupants during a stop. This is just one example how an alert officer's conversation during a stop was able to apprehend a wanted person. When subjects do not have proper identification, officers may ask several questions to verify the identity of that person.

If you happen to find yourself or a friend stopped by a police officer you may better understand the line of questioning and appreciate the officer's responsibility/obligation in properly identify all subjects stopped.

SUSPECT IDENIFIED AFTER OFFICERS USE NEW FINGERPRINT SCANNER

On Friday, September 1, 2017, at 11:30 pm PFC Giles and Ptlm. Fortino stopped Jose Diaz, a 36-year-old male from the unit block of Barclay Hall, Newark, for not having proper lighting on his bicycle. While attempting to identify the subject, Ptlm. Fortino suspected he was giving a false name. Ptlm. Fortino asked several standard questions used to help verify a person's identity. Diaz had trouble answering all of these questions and PFC Giles used a newly obtained fingerprint scanner to assist.

While the officers returned to their vehicle to use the scanner, Ptlm. Fortino remained alert and observed Diaz attempting to throw items from his pocket in a grassy area. Diaz was detained and the items proved to be 6 bags of heroin, 1 bag of crack, and 1 bag of cocaine. When the officers told Diaz that they were waiting for conformation from the scanner, he bowed his head and stated, "OK, you got me". It was then learned that the New Castle County Police also wanted Diaz for Assault and New Castle City Police for Resisting Arrest where he ran from officers attempting to identify him after being stopped for bicycle violations on 08/31/2017.

In addition to his outstanding warrants, Diaz was charged with the following: Improper Bicycle Lights/Reflectors at Night, Possession of Heroin, Possession of Crack, Possession of Cocaine, Possession of Drug Paraphernalia, and Criminal Impersonation. He was committed to Howard Young Prison after failing to post cash bail.

JUVENILE STOPPED ON A BICYCLE LEADS TO DRUG ARREST

On Thursday, September 21, 2017, Ptlm. Macdowell stopped a 17 year old male from the 200 block Linden Ave. in Elsmere for numerous bicycle violations. Ptlm. Macdowell recognized the male from previous interactions and was aware that he had an active capias for his arrest. During the stop Ptlm. Macdowell located 25 individual containers of crack packaged for sale in the suspect's pocket. Ptlm. Macdowell obtained a search warrant for the suspect's residence which was executed by Elsmere and Wilmington Police Officers. The 17 year old suspect was charged with the following: Failing to Have a Required Helmet (Delaware law requires persons under 18 wear a helmet while riding a bicycle), Failure to Signal a Turn While Riding a Bicycle, Failing to Stop at a Stop Sign, Possession of Marijuana, Possession of Crack, and Possession with the Intent to Deliver Crack. He was released to his parent on \$1,300.00 unsecured bail. A name and arrest photo will not be released due to the defendant being a juvenile.




Drug and Money Seizure

As a result of a month long drug investigation, officers from the Elsmere Police Department were able to arrest Carl Harris (56 years old) and Shawn Marshall (23 years old) for drug dealing charges. Officer MacDowell was the lead investigator and acquired a search warrant for the unit block of Tamarack Avenue. On September 26, 2017, the search warrant was executed with the assistance from the Wilmington Police Department's SWAT Team. Crack cocaine and marijuana that was packaged for sale was seized. \$1,371.55 in drug proceeds was also collected.

Both Harris and Marshall were charged with drug dealing and associated drug charges. Harris was released on \$8,050.00 unsecured bail on the drug charges. Marshall was released on \$3,000.00 unsecured bail on his charges.
