Significant Events:

On the following dates/times Elsmere Bureau of Police officers handled the below incidents and seized the following drugs, money and/or weapons.

March 3, 2018:

Speeding Leads to Drug Arrests

On March 4, 2018, S/Cpl. Kerrigan stopped Def.#1 John Hayward of the 100 Blk. of Pennsylvania Avenue, Claymont for speeding. Def. #2 Jennafer Machado of the 300 Blk. of S. Parkway Blvd., Broomall, PA was the passenger in the vehicle. During the course of the traffic stop, S/Cpl. Kerrigan was able to develop enough probable cause to search and located 69 bags of Heroin, 12+ grams of cocaine and \$742 in USC.

D-1 (Hayward) was charged with the following:

- 3 Counts of Possession of Controlled Substance
- 3 Counts of Manufactures, Delivers or PWID
- Several traffic offenses

D-2 (Machado) was charged with the following:

- 1 Count of Possession of Drug Paraphernalia

March 12, 2018:

Explosive Device Arrest

On Monday, March 12, 2018, Elsmere Bureau of Police along with assistance from NCCPD (EOD Unit), Delaware State Fire Marshall Office, ATF and FBI did investigate an incident in which an explosive device was used to cause damage to a property in the 1300 Cypress Avenue. A lengthy investigation was completed by these agencies and

Mark Consiglio of the 700 Blk. of Baltimore Avenue was arrested and charged on the following crimes:

- Bombs Incendiary Devices Molotov Cocktails and Explosive Devices (3 Counts)
- Poss Purch Own or Control of a Deadly Weapon by a person prohibited (18 Counts)
- Endangering the welfare of a child (2 Counts)
- Criminal Trespass 2nd
- Breach of Release

The defendant's bail was set at \$106,200.00 secured and was committed to Howard Young Correctional Facility.



March 16, 2018:

On Friday, March 16, 2018, officers were dispatched to 300 Blk. of Taylor Road for a theft in progress. The reporting person (RP) stated that the suspect was ripping copper pipes out of the walls of a vacant home. Prior to officer's arrival the RP stated that the suspect was fleeing in a white "Roto-Rooter" van. PFC Giles stopped the van on Dupont Road at Charlie's Liquors and stopped Thomas White of the 300 Blk. of Taylor Road.

It was determined that Def. Thomas entered the vacant property through an unsecured rear door. Once inside he breached numerous walls and removed copper water pipes. Def Thomas was charged with Burglary 3rd, Theft under \$1500, Criminal Mischief Tamper with Utility, Possession of Burglar Tools and Manufactures, Uses, Displays, or Advertises a Counterfeit Trademark. Def. was released on unsecured bond.
