> Town Manager John Giles stated that there will be a payment authorization request submitted for the purpose of reimbursing the Town for funds which were

expended in 2018 during the change in trustees which were paid for with the Town's general fund but are qualified expenses from the Pension.

- \$18,160.00 for Wilmington Trust Management Fees
- \$14,000.00 for Legal Services during the Transition
- \$6,300.00 for the Actuarial Study
- \$3,156.00 for First State Trust Fees
- \$2,419.00 for additional Legal Fees during the Transition

For a total of \$44,071.16 which should have been charged directly to the pension.

We plan to have a clearer grasp on the expenses for the various plans in the upcoming year. We will be separating legal bills based on the plan discussed to ensure that only costs associated with the Original Police Pension plan are what is being paid from that plan and being paid on a timely basis. Costs for other plans will need to be paid by the Town because there are no assets to pay costs from.

Old Business:

- 1. Items for the Elsmere Police Secondary Pension Plan
 - a. Consideration of a final decision concerning a disbursement made from the Elsmere Police Secondary Pension Plan.

Town Manager John Giles and Acting Finance Director Steve Martin gave a brief overview of the issue and stated that there is a total of \$1,317.98 owed for loss earning to make the plan whole and close out this lengthy pending issue. If the payment is not made by December 31, 2019, the amount will increase. The question comes whether the employee will be required to pay the full amount or if the Town will pay a portion of the loss earnings.

Mayor Thompson stated that he believes the employee should be responsible, however, he believes the Town should make the initial payment to ensure it is made in a timely manner, then the employee should be required to sign an agreement to have a payroll deduction for the reimbursement of fees until satisfied.

ACTION: A motion was made by Mayor Thompson to make the pensioner responsible to pay the full \$1,317.98 of loss earning to plan. The motion was seconded by Committee Member Franzone.
