### **Ordinance 658**

# AN ORDINANCE REPEALING ORDINANCE 654, THEREBY REPEALING THE MORATORIUM ON THE REVIEW OR HEARING OF AN APPLICATION TO THE PLANNING COMMISSION OR BOARD OF ADJUSTMENT WHICH IN ANY MANNER INCREASES IMPERVIOUS LOT COVERAGE.

**WHEREAS,** The Mayor and Council of the Town of Elsmere adopted Ordinance 654 in order to allow time to study and determine the Town's current position as it relates to the amount of impervious lot coverage throughout the Town; and

**WHEREAS**, The Town was able to obtain the information which it was seeking during the month of January 2021 and there is no longer a need to have the moratorium established by Ordinance 654.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF ELSMERE, AS FOLLOWS:

Effective March 12, 2021 Ordinance Number 654 and the moratorium established by that Ordinance are hereby voided.

### SYNOPSIS ORDINANCE 658

This Ordinance repeals Ordinance 654 which was an Ordinance that placed a one (1) year moratorium of the review or approval of any application before the Planning Commission or Board of Adjustment which if approved would increase the amount of impervious surface on the subject property. Any application which may have been submitted prior to December 11, 2020 was permitted to continue through the application process, and anyone who could prove an actual hardship related to a disability or accessibility issue was not be affected by the moratorium established by this ordinance.

#### **Fiscal Impact:**

This Ordinance is anticipated to have no Fiscal Impact. Since any fees paid would go toward the cost of holding the hearing (such as the deposit on signs) and during the Fiscal year have already been budgeted.
