# A RESOLUTION SETTING THE FEES ASSOCIATED WITH THE TOWN'S REQUEST TO CHANGE THE TOWN CHARTER TO ALLOW THE CREATION OF A VOLUNTARY ASSESSMENT CENTER IN THE TOWN OF ELSMERE FOR THE PAYMENT OF TRAFFIC AND PARKING VIOLATIONS.

**WHEREAS**, The Mayor and Council by passing Resolution 21-04 have shown that they wish to establish a Voluntary Assessment Center in the Town of Elsmere; and

**WHEREAS,** In order to establish the Voluntary Assessment Center the Town must amend its existing Home Rule Charter; and

**WHEREAS**, the method of amending the Town's Home Rule Charter requires the Delaware Legislature to approve any change;

**WHEREAS**, the Mayor and Council have requested that State Representative John L. Mitchell and State Senator Spiros Mantzavinos to introduce to the Delaware General Assembly a bill which would allow the Town of Elsmere to establish a Voluntary Assessment Center within the Town: and

**WHEREAS,** should this request be honored and ultimately accepted by the General Assembly, the town will need to establish certain fees associated with the operation of the VAC.

# NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND COUNCIL, THAT;

Should a VAC Center be authorized by the General Assembly, that the following fees shall be charged for each summons submitted; and these fees shall be in addition to any other fine or fee associated with a mandate to be charged by the Delaware General Assembly.

The following fees shall be charged on each summons or ticket processed:

\$20.00 as an administrative fee; and

\$10.00 as a security fee
