Service Provider is in the business of providing equipment maintenance services, and hereby undertakes to provide the following maintenance services to Client:

Service #2: AT HOME SERVICE

Mid Mower Serviced: --

Service Provider shall ensure that all services provided under the terms of this contract are performed by persons trained and certified as proficient in the provision of the services provided by an accredited school or manufacturer's training program.

Service Provider represents and warrants that all personnel provided by Contractor to do work on Client's equipment are legally eligible to work in the United States of America; and that Contractor complies with all applicable federal and state wage and employment laws, and with all other applicable laws and regulations pertaining to the services provided to Client.

In consideration of services provided by Service Provider, the Client agrees as follows:

1. To pay to Service Provider the sum of **\$495.15**, which includes all applicable taxes and transportation costs.
2. All repairs due to damage, misuse, and accidents outside of normal wear and tear will NOT be included in this agreement and will only be fixed after approval from the Client for additional costs.

This contract shall expire on *March 31, 2022*, at which time the Client may extend it by purchasing an additional maintenance package for the equipment. Either party may terminate this contract at any time by providing written notice of intent to terminate the contract on a specified date to the other party, at least two weeks prior to the intended date of termination. Upon termination, any annual service not yet performed will be refunded in the same manner for which it was paid.

**SERVICE TERMS:** Client agrees to provide Atlantic Tractor access to the above referenced **XUV 590i**, between *October 1 and February 28* for each AT Home Service, and within 20 hours of each 50 Hour Service to perform the services included in this Hassle-Free Ownership Plan. Failure to provide access may result in additional charges and service delays.

Any dispute or cause of legal action that may arise from either party's performance under this Contract shall be governed by the laws of the State of Maryland and applicable federal law. Any litigation arising from this Contract shall be filed and tried in the Service Provider's local jurisdiction.
