Materials

1. Install (12) tamper proof rodent stations on interior perimeter of the facility, in garage and offices. Stations will be clearly labeled and barcoded. Monitoring and trapping will be attempted before rodenticide is utilized.
2. Place insect and/or rodent monitors in areas susceptible to pest pressure (food storage, water sources, etc.).

Monthly Service

3. Respond to any complaints that have occurred since the previous visit.
4. Service interior stations.
 - a. Clear stations of dirt and debris and ensure that entry is accessible to rodents.
 - b. Replenish any damaged or consumed bait.
 - c. Replace or repair any damaged bait stations.
5. Inspect and replace insect and rodent monitors.
6. Treat any pest populations discovered or reported using IPM methods.
7. Perform preventative treatments in areas where pests tend to breed, congregate, or enter structures.
8. Supply maintenance staff with service reports that includes materials used, services performed, and recommendations for sanitation or mechanical alterations.
9. Covered pests include ants, cockroaches, and all other commonly occurring structural pests. Specifically excluded will be bed bugs, fleas, mosquitos, ticks, stinging insects, termites, bats, birds & wildlife control. If treatment is required for a non-covered pest, a separate proposal will be given.
