**A RESOLUTION INCREASING THE AMOUNT OF ADMINISTRATIVE
COST CHARGED WHEN AN ELSMERE POLICE OFFICER WORKS WHAT IS
KNOWN AS AN EXTRA DUTY ASSIGNMENT**

WHEREAS, the officers of the Elsmere Bureau of Police are frequently called upon to work on their off-duty time for a particular need; and

WHEREAS, this action is permitted by the Town and is known as an Extra Duty Assignment; and

WHEREAS, the hourly cost associated with an extra duty assignment consists of three parts, the hourly amount which the officer is paid and which is determined by the Chief of Police, costs which are incurred by the Town for each hour that an officer works and is determined by the Mayor and Council, and costs incurred for the wear and tear on the police vehicles; and

WHEREAS, the Mayor and Council have determined that it would be appropriate to add to the administrative cost for an extra duty assignment a fee.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF
THE TOWN OF ELSMERE, THE FOLLOWING:**

1. This resolution shall become effective January 01, 2022; and
2. At that time the Administrative cost charged by the Town for each hour that an Elsmere Police Officer works an Extra Duty Assignment shall be twenty five dollars (\$25.00) per hour; and
3. The Twenty Five-dollar (\$25.00) charge shall be applied as follows, seven dollars (\$7.00) being applied to the administrative cost associated with the Finance Department, eight dollars (\$8.00) being applied to the investment pool of the Elsmere Bureau of Police Pension Fund, and ten dollars (\$10.00) to be applied for the use of the police vehicles.

SYNOPSIS
Resolution 18-04

This resolution increases the Town's administrative cost for an Extra Duty Assignment to accommodate for the wear and tear incurred on the Police Vehicle. It also increases the amount charged for the police pension.
