Unique Image fell into financial hardships and had to close the location in Lewes. Instead of having a new sign built, they are seeking to move the sign from Lewes to Elsmere since it is already an existing sign and purchasing a new sign is not feasible.

Chairman Personti stated that in reviewing the recommendation from the Planning Commission and seeing the property needs to be brought into compliance, asked should this petition be heard.

Board Member Russo stated we should hear the petition and if it is approved make the approval conditional to the property being compliant with the Town.

Petitioner Lyndsey asked if Unique Image could apply for a variance for the murals.

Code Enforcement Officer Allen stated that the murals are not compliant with the Town's color pallet and need to be corrected.

Chairman Personti asked if there was any public comment for Petition 22-07 and received none.
