## Items for the Elsmere Police Pension Plan.

- Review and approval 2022 Actuarial Report.
- Councilwoman Steppi stated that she has reviewed the 2022 Actuarial Report and was more favorable. This time last year due to better market.
- Finance Director Steve Martin stated that he can say it's been a better market.
- Neal Strauss stated that the market bounced up to 72% from 64 %.
- Attorney Mr. Snyder stated that next year may not look so good.
   Chairman Strauss stated by next year we will take a hit. He asked what average is for national pensions are as far as for what they are funded at?
- Attorney Mr. Snyder stated it depends on if it's a private plan or governmental plan. Governmental plans are notoriously way underfunded. Most employees don't have pension plans anymore; they have 401k's. It depends on what segment of the economy you're looking for.
