## Ordinance 668

**WHEREAS,** on April 20, 2023 the "Owner" of the property known as #1 Spruce Avenue submitted Petition 23-07 requesting the Mayor and Council to rezone the property in order to allow a commercial use; and

**WHEREAS,** the Planning Commission has been provided an opportunity to review the request and make a recommendation to the Mayor and Council; and

**WHEREAS,** the Mayor and Council in keeping with the intent of the Comprehensive Plan of the Town of Elsmere, wish to support the growth of our local businesses while encouraging the redevelopment of structures throughout the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF ELSMERE, THE FOLLOWING:

That the Zoning Map of the Town of Elsmere is hereby amended by changing the zoning of Tax Parcel Number 19-004.00-010 also know as #1 Spruce Avenue from its current R-1, Residential District zoning classification to a CC, Community Commercial District zoning classification.
