**Review Petition 24-01 Tax Parcel # 19-00400-520** 

The applicant seeks to appeal citations V2300749, V2300799, V2400533 and V2400581 issued by the Code Enforcement Department. The Board of Adjustment will review and render a decision regarding this petition.

The Applicant, Timothy Graff was not present for the meeting nor was a representative on their behalf. The Board of Adjustment still chose to hear the appeal.

Code Enforcement Officer Nicole Facciolo stated there have been multiple violations at this property in the 12-month period beginning in June 2023. She noted that as of today's date March 26, 2024, the property was still in violation for the non-renewal of their Town of Elsmere's rental license that was due no later than October 31, 2023. Also, there was only one Citation that could have even appealed due to the 20-day appeal process. This is V2400581, dated 01/31/2024, (\$1,000 Public Nuisance fine).

Councilwoman Mary Steppi, 3<sup>rd</sup> District, spoke on behalf of her district that she has noticed a decline in the properties on Birch Avenue. She gave her opinion that Landlords have been using the same excuse about why they have not received their citations or fines.

Town Manager Steven Martin, agreed with Councilwoman Steppi and the Code Department statement's that the Town has met its intent with the evidence provided and testimony given.
