Review Petition 24-08 Tax Parcel # 19-00800-130

The applicant seeks to add 640 sq. feet of impervious coverage in the rear for parking. The Board will review and render a decision regarding this petition.

The applicant was asked to provide an opening statement. In her statement, Denise Purnell Cuff stated that she has been a long-time resident of over 20 years in the Town and is seeking this approval due to a medical necessity for her ailing husband to be able to get to and from the car in a safe manner. Her request is to install a 640 sq. foot driveway at the back of the house. Currently, the rear yard is unsafe for him to maneuver. She would like to install the coverage so that she can pull the car right up to the rear door and he can get inside the residence with no issues.

Code Enforcement Officer Nicole Facciolo read the site analysis from the Building Official. She also stated that the Town has no opposition to this variance request, and it should be considered for approval since this is a true medical hardship.

Multiple questions were asked by the Board Members as to the size of the driveway and as to the dimensions of it. Could a smaller driveway be installed?
