Administrative Assistant for the Code Department Denise Lardani read the opening statement.

#### **NEW BUSINESS:**

### 1. Review Petition 25-01, Tax parcel number 1900-500-190

The applicant seeks to expand the rear porch from 7' x 15'6" to 16' x 15'6. The Planning Commission will review and make a recommendation to the Board of Adjustment.

The applicant Edgar Molina stated that his porch is currently in disrepair and needs to be torn down and rebuilt. While rebuilding it he is seeking to make the porch a little bigger.

Code Enforcement Officer Nicole Facciolo read the site analysis from the Building Official. She also stated the at the Town has no opposition to the variance request.

**ACTION:** Commissioner Dyer made a motion to approve expansion of the rear porch and approve the variance from the Town Code 225 attachment #3 to allow for a zero-yard side setback in lieu of the required 5 feet. Commissioner Holloway seconded the motion.

## 2. Review Petition 25-02, Tax parcel number 1900-400-389

The applicant seeks to add 156 sq. feet of impervious lot coverage via a three-season room. The Planning Commission will review and make a recommendation to the Board of Adjustment.

The applicant/representative was asked to provide an opening statement. He stated that they are looking to construct a three-season room on top of an existing foundation. There is no additional coverage being added.

Code Enforcement Officer Nicole Facciolo read the site analysis from the Building Official. She also stated the at the Town has no opposition to the variance request. The reason for having to attend the meeting is because the room is being enclosed with a roof.

**ACTION:** Commissioner Czerwinksi made a motion to approve three-season room and grant the variance from Town of Elsmere Code 225 Attachment #3 to allow for a 42% lot coverage in lieu of the required 30%. Commissioner Holloway seconded the motion.
