



## **Deeded Parking Program**

The Town of Elsmere is launching a program to help residents who are experiencing difficulties with their deeded parking spaces. The program's goal is to increase awareness among neighbors and visitors that parking in rear alleyways or other deeded areas assigned to specific addresses is not for public use.

Under the program, homeowners can obtain Town-approved signage that displays the address to which the space is deeded. The cost for the signage to be installed is \$50.00. Any changes to your application after the initial installation will be subject to a \$15.00 charge. Applications can be found on our website at [www.townofelsmere.com](http://www.townofelsmere.com) or picked up at Town Hall (11 Poplar Avenue).

Once an application has been completed and returned to Town Hall with proof of the property deed, it will then be processed. The Code Enforcement Department will ensure that your property does have a deeded parking space. The Finance Department will ensure that there are no taxes or fines due on the property. Then you will be contacted with the approval or denial of the application. If approved, payment must be made for the parking signage to be issued. Payments can be made with the Finance Office at Town Hall.

The signage can then be installed in the designated parking spot accordingly. If a vehicle violates the signage, the homeowner can contact the Elsmere Police Department to have the vehicle removed at the vehicle owner's expense.
